PROGRAMA GANHANDO O MUNDO DA CIÊNCIA

MEMORANDUM OF UNDERSTANDING

BETWEEN

ARAUCARIA FOUNDATION

AND

PARTNER INSTITUTION

(Partner Institution) and Araucaria Foundation (henceforth Araucaria), henceforth referred to individually and collectively as Party/Parties, in accordance with the principles of equality and mutual benefit and by means of friendly negotiation, agree to establish a collaboration agreement for the purpose of providing the exchange of students and researchers, (henceforth the “Participant”) to carry out academic disciplines, scientific internships, teaching and in industry, in order to strengthen international collaborations between the State of Paraná and (host country) in the name of the Program *Ganhando o Mundo da Ciência* (Getting the World of Science Program).

This Memorandum of Understanding will come into force for three years with beginning in xxxx, **xx** of 20xx and conclusion in xxxx, **xx** of 20xx. It can be terminated by any of the Parties, upon notification with six months of antecedence in the intent of doing so. The participants admitted in the program will continue to receive support in the level and time set above. The Memorandum will be revised during its third year operating. If both the Parties have no objections the contract will be renovated for three more years upon written confirmation.

Any financial commitment from Araucaria or **(Host Institution)** in this Memorandum will be valid and executed based on budget availability for the Program. **No academic fees or other will be paid by Araucaria Foundation, neither by the students, under this Program to the Host Institution.** The Parties will coordinate any public communications about the initiative, including announcements and press releases.

The Parties must cooperate with each other and provide all necessary documentation to support reporting requirements to their respective governments and funding partners and/or the creation of annual reports related to the initiative.

Each Party shall inform the other of the need to change the eligibility requirements for Participants to receive financial support to participate in the initiative and shall promptly inform the other of any

changes to the financial requirements or obligations imposed on applicants to participate in the initiative. Any proposed changes shall be communicated in writing to allow 12 weeks for any notice of change to take effect.

The **host institution** will be responsible for filling in the information required on the institutional offer form, which will inform them of all the requirements for student eligibility, as well as the number of vacancies, modalities, areas and other additional information.

Araucária does not claim any ownership of Intellectual Property developed through funded research projects and internships. It is recommended that participating institutions undertaking a research collaboration reach a mutual understanding of the Intellectual Property implications of the project(s). **(Host Institution)** will notify Araucária of any future updates to the Intellectual Property policies of **(Host Institution)**.

Araucária and **(Host Institution)** mutually recognize and agree that, for the purposes of fulfilling their respective obligations under this Memorandum, they will share the necessary personal information of their respective Participants in this Memorandum. Araucária and **(Host Institution)** mutually agree that they will treat such personal information in accordance with local legislation in this regard.

The **host institution** and Araucária confirm that, to the best of their knowledge, the program, as implemented in their respective countries, complies with all applicable laws.

This Memorandum and all attached appendices form part of this Memorandum. This Memorandum may be modified and supplemented by mutual consent of the **host institution** and Araucária. Matters not included in the Memorandum, but directly related to it, may be dealt with by agreement of the Parties. Any such agreement must be attached to this Memorandum and become valid on the date of signature.
