Concept

In the 7th century AH, remarkable strides were undertaken across the arts and sciences. The inaugural conference in Djelfa, Algeria was convened six years ago to begin uncovering this rich heritage. Subsequent conferences in prominent cities—such as Istanbul and Bursa in Turkey, Granada in Spain, Tunis, and Cambridge in England—further advanced these efforts. In the years ahead, God willing, additional dimensions of this intellectual legacy will come to light.

However, conferences alone cannot encompass the depth and breadth of this endeavor. It is imperative to explore other channels that delve more profoundly into the intricate intellectual landscape of this vibrant and illustrious century. This requires tracing the subtle connections that interlace its scientific and civilizational fabric. To this end, we have resolved to complement the annual conference with symposia, each dedicated to a specific theme within the scientific, cultural, and civilizational framework of the century. This initiative aims not only to further the overarching objectives but also to address areas that may have been overlooked amid the vast scope of this epoch's intellectual achievements.

What better theme with which to inaugurate this series of symposia than the first Arabic-Islamic codex: the Noble Qur'an? The codex of the Noble Qur'an bears the Word of God which is the foundational source from which all Islamic sciences have sprung. Given that these sciences are the focal point of these 7th-century focused conferences, this symposium will concentrate on the manuscript as artifact. Our focus will be strictly codicological, examining its craftsmanship and formal properties—specifically, the traditions of its production and the artistry by which it is adorned.

Where has the Craftsmanship and Aesthetics of the Noble Qur'an Reached?

Centuries have passed since the efforts of the Noble Companions to compile the Holy Qur'an during the lifetime of the Prophet Muhammad (peace and blessings be upon him), culminating in the compilation of the Qur'an by the third caliph, Uthman ibn Affan (may Allah be pleased with him). Undoubtedly, during the 7th century, the codicological structure and appearance of the Qur'an manuscript evolved by the skill of Muslim craftsmen and matured with the rich cultural exchanges of the many peoples who embraced the religion of Allah en masse.

These devoted hands would show no less care for the manuscript carrying the words of Allah than for those books reserved for caliphs, kings, and nobility.

We are thus confronted with the pinnacle of Islamic manuscript-making, both in craftsmanship and form. The central question of this symposium is: Did the writing of Qur'an manuscripts truly reach its zenith of productive splendor in the seventh century? A splendor based on the availability of precious materials such as fine paper, high-quality inks, and gold pigments; on the development of exquisite tools like pens, rulers, and precious polishing stones; on the diversity of creative industries with their grand styles, shapes, and sizes; and on the distinction of calligraphic arts such as script, ornamentation, gilding, and binding. These elements greatly contributed to the transformation of Qur'an manuscripts towards a refinement of craftsmanship, a grandeur of art, and a massiveness of size, among other characteristics of the treasury manuscripts that distinguished this century. Suffice it to say that the collections of Mamluk Qur'ans preserved in the treasuries of Arabic and Islamic manuscripts worldwide attest to this. Regarding this matter, numerous questions arise, which a group of scholars and specialized manuscript experts will gather to study and explore their dimensions.

Themes

Bibliographic Theme: The Heritage of the 7th- Century AH Qur'an Manuscripts and their cataloguing

- The heritage that has reached us and its distribution among Arab and Islamic libraries around the world
- loss and disappearance of texts on the one hand; preservation and survival on the other.
- efforts made for cataloguing, digitization, and database design.

Codicological and Calligraphic Theme: The life of 7th- Century AH Qur'an Manuscripts and their internal structure:

- Sources of production and geographical affiliations, and the implications of these religious, scientific, social, historical, and civilizational affiliations.
- The material structure (paper and leather) and the traditions of craftsmanship, and the extent of their connection to previous centuries.
- The lines, their types, characteristics, and their relations to their historical roots.
- The scribes and binders, their classes, biographies, works, and their presence in sources.
- The shapes, sizes, weights, and their functions, as well as the circumstances surrounding their production.
- Subsequent and modern efforts serving the life of the Qur'an manuscripts and their internal structures.

Aesthetic Theme: The Form of 7th- Century Qur'an Manuscripts and their Craftsmanship

- The decoration of pages, characteristics of illuminations, colors, and the geographical dimensions.
- The construction of pages, distribution of content, linear formation, and the aesthetic implications of all this.
- The decorators, illuminators, and scribes, their classes, biographies, affiliations, and their works and presence in sources.
- Subsequent and modern efforts serving the image and its arts.
